No. GE/P/42 of 1980/TPS-4277/334(80)-Q :- WHEREAS under Government Notification, Panchayats and Urban Development Department No. GE/P/206 of 76/TPS-4276/4242-Q, dated 26th August 1976, the Town Planning Scheme, Surat No. 3 (Kavargam-final) (hereinafter referred to as the said scheme) came into force from 11th October, 1976;

AND WHEREAS the Government of Gujarat considered the said scheme to be defective on account of an error;

AND WHEREAS the Government of Gujarat was satisfied that the variation required in the said scheme is not substantial;

AND WHEREAS the Government Notification, Panchayats, Housing and Urban Development Department No. GE/P/98 of 1979/TPS-4277/760(79)-Q, dated the 6th June 1979 containing the draft variation has been duly published in the Gujarat Government Gazette, Part IV-B, dated the 21st June 1979 on page No. 770 and also in the 'Gujarat Mitra' daily newspaper;

AND WHEREAS - necessary action for keeping and affixing the copies of the Government Notification, Panchayats, Housing and Urban Development Department No. GE/P/98 of 1979/TPS-4277/760(79)-Q, dated 6th June 1979 has been duly taken by the Surat Municipal Corporation;

AND WHEREAS no objections to the draft variation have been received by the State Government through the Collector under sub-section (5) of the section 70 of the Gujarat Town Planning and Urban Development Act, 1976 (President's Act No. 27 of 1976).;

AND WHEREAS the State Government has consulted the Surat Municipal Corporation, the Chief Town Planner to Government and the Collector of Surat in the matter;

NOW THEREFORE, in exercise of the powers conferred by sub-section (6) (b) of the Section 70 of the Gujarat Town Planning and Urban Development Act 1976, the Government of Gujarat hereby:-

"Sanctions the variation in the aforesaid Town Planning Scheme Surat No. 3 (Kavargam final) as set-out in the schedule appended hereto".
