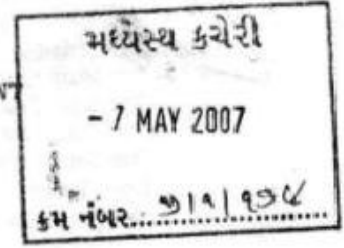

THE GUJARAT TOWN PLANNING AND URBAN DEVELOPMENT ACT, 1976.

NO.GH/V/142 of 2007-TPS-1406-1100-L : WHEREAS, under Government Notification, Urban Development and Urban Housing Department No.GH/V/85 of 2002/TPS-142001/860-L, dated 27/06/2002 the Government of Gujarat, in exercise of the powers conferred by section 48(2) of the Gujarat Town Planning and Urban Development Act, 1976 (President's Act No. 27 of 1976) (hereinafter referred to as "the said Act ") sanctioned the Draft Town Planning Scheme, Surat No. 14 (Pal) SUDA (hereinafter referred to as "the said Draft Scheme") submitted by the Surat Urban Development Authority, SUDA (hereinafter referred to as " the said Authority" )

AND WHEREAS, in exercise of the powers conferred by section 50 of the said Act, the Government of Gujarat appointed the Town Planning Officer for the finalizing the said Draft Scheme ;

AND WHEREAS, the Town Planning Officer has submitted, to the Government of Gujarat, the Preliminary Town Planning Scheme, No. 14 (Pal) SUDA (hereinafter referred to as " the said Preliminary Scheme") as required under section 52(2) and section 64 of the said Act.

NOW THEREFORE, in exercise of the powers conferred by section 65 of the said Act, the Government of Gujarat hereby :-

- Sanctions the said Preliminary Scheme with modifications enumerated in schedule appended here to ;
- States that the said preliminary scheme shall be kept open for the inspection of the public, at the office of the said Authority, during office hours on working days;
- Fixes the 28-05-2007 as the date for the purpose of clause (b) of sub-section (2) of the section 65.


