WHEREAS, under Government Notification, Urban Development and Urban Housing Department No.GH/V/340 of 1993/ TPS - 1492-2449- L, dated 24-12-1993 the Government of Gujarat had in exercise of the powers conferred by sub-section(2) of section 48 of the Gujarat Town Planning and Urban Development Act, 1976 (President's Act No.27 of 1976) ( hereinafter referred to as " the said Act") sanctioned a draft Town Planning Scheme, Surat No.21 ( Bhestan) ( hereinafter referred to as " the said scheme") submitted to it by the Surat Urban Development Authority, Surat;

AND, WHEREAS, in exercise of the powers conferred by Section 50 of the said Act, Government of Gujarat appointed the Town Planning Officer for the said draft Town Planning Scheme;

AND, WHEREAS, the Town Planning Officer has submitted to the Government of Gujarat the Town Planning Scheme, Surat No.21 (Bhestan) - Preliminary Scheme ( hereinafter referred to as " the said Preliminary Scheme")

as required under sub-section (2) of section 52 and section 64 of the Gujarat Town Planning and Urban Development Act, 1976 ( President's Act No.27 of 1976);

NOW, THEREFORE, in exercise of the powers conferred by Section 65 of the Gujarat Town Planning and Urban Development Act, 1976 ( President's Act No.27 of 1976) the Government of Gujarat hereby :-

- (a) Sanctions "the said preliminary scheme"--- without modification;
- (b) Specifies that the said preliminary scheme shall be kept open to inspection by the public at the office of the Surat Urban Development Authority, Surat during office hours on all working days;
- © Fixes the 29 March, 2000 as the date for the purpose of clause(b) of sub-section (2) of the said Section 65.
