AND WHEREAS, under Government Notification, Urban Development and Urban Housing Department No.GH/V/73 of 2008/TPS-1407-5-L, dated.20.05.2008 the Government of Gujarat, in exercise of the powers conferred by section 65 of the said Act 1976, sanctioned the Preliminary Town Planning Scheme No. 26 (Singapore);

AND WHEREAS, the Town Planning Officer submitted to the Government of Gujarat, the Final Town Planning Scheme No. 26 (Singapore) (hereinafter referred to as "the said Final Scheme") as required under sub-section (2) of section 52 and section (2) of section 62 of the said Act;
