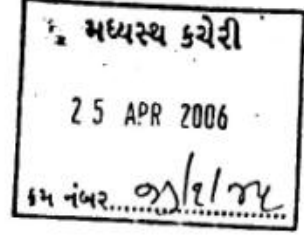

THE GUJARAT TOWN PLANNING AND URBAN DEVELOPMENT ACT, 1976.

NO.GH/V/113 of 2006-TPS-1405-830-L : WHEREAS, under Government Notification, Urban Development and Urban Housing Department No.GH/V/57 of 2000/TPS/1499/1588-L dated 28/02/2000 the Government of Gujarat, in exercise of the powers conferred by sub-section (2) of section 48 of the Gujarat Town Planning and Urban Development Act, 1976 (President's Act No. 27 of 1976) (hereinafter referred to as " the said Act " ) sanctioned the Draft Town Planning Scheme Surat No. 31 ( Adajan ) ( hereinafter referred to as " the said Draft Scheme " ) submitted by the Surat Municipal Corporation, Surat.

AND WHEREAS, in exercise of the powers conferred by section 50 of the said Act, the Government of Gujarat appointed the Town Planning Officer for finalizing the said Draft Scheme ;

AND WHEREAS, the Town Planning Officer has submitted to the Government of Gujarat the Preliminary Town Planning Scheme 31 (Adajan) (hereinafter referred to as " the said Preliminary Scheme " ) as required under sub-section (2) of section 52 and 64 of the said Act.

NOW THEREFORE, in exercise of the powers conferred by section 65 of the said Act. the Government of Gujarat hereby :-

(a) sanctions " the said Preliminary Scheme ", with modifications enumerated in the schedule appended hereto ;

(b) states that the said Preliminary Scheme shall be kept open for inspection, by the public, at the office of the Surat Municipal Corporation, Surat during office hours on all working days.


(c) Fixes the 20-05-2006 as the date for the purpose of clause (b) of sub-section (2) of the section 65 of the said Act.
