Sub: Veer Narmad South Gujarat University - Recognition of MD(Tuberculosis & Respiratory Diseases / Pulmonary Medicine) qualification for 03 seats in respect of students being trained at Surat Municipal Institute of Medical Education & Research, Surat.

I am to state that the General Body of this Council at its meeting held on 22/11/2016 considered the Compliance Verification Assessment Report (18/04/2016) along with the Council Assessor's Report (April, 2015) and compliance dated 03/11/2015 submitted by the college authorities on the physical and other teaching facilities available at Surat Municipal Institute of Medical Education & Research, Surat for the award of MD(Tuberculosis & Respiratory Diseases / Pulmonary Medicine) qualification for 03 seats under Veer Narmad South Gujarat University. The Council approved the following recommendations of the Postgraduate Medical Education Committee, which I am directed to convey herewith for your information and necessary action:-

"The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (18/04/2016) along with the Council Assessor's Report (April, 2015) and compliance dated 03/11/2015 submitted by the college authorities and decided to recommend to the Central Government that MD(Tuberculosis & Respiratory Diseases / Pulmonary Medicine) qualification for 03 seats granted by Veer Narmad South Gujarat University in respect of students being trained at Surat Municipal Institute of Medical Education & Research, Surat be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."

You are therefore requested to notify the above qualification at the earliest.
